As per the letter read as 1st paper above, the Director,Dairy Development Department has submitted a proposal for Establishing “Dairy Innovative Zone” in the State by collaborating with Kerala State Start-up Mission (KSUM) with a State plan outlay of Rs 10.00 lakh (Rupees Ten Lakh Only) earmarked to the Dairy Development Department under the State Plan Scheme :Rural Dairy Extension and Advisory Services with H.O.A 2404-00-102-96-34-3 Other Items.

Objective of Innovation Zone are as follows;

1. Compile an indicative list of problem statements and identify the problems which can be addressed by using technology
2. To source or scout for ideas and solutions for solving the listed problems and to facilitate the adoption of useful ideas and technologies after due testing.
3. providing a platform for researchers and innovators in different technologies to converge and develop cost effective, timely and efficient solutions to support Dairy.
4. To come up with mechanisms and draft regulations for testing and adopting new technologies.
5. To support aspiring entrepreneurs engaging in this field with a platform to showcase their ideas and pitch for funding further development/sale.
6. To strengthen the innovation culture within the department by providing the opportunity to work with start ups to co-develop tech solutions for existing problems.
7. To bring in industry partners and investors to scale the product developed for the innovation zone.

The Departmental Working Group held on 03.08.2022 recommended the proposal to accord Administrative Sanction with a condition that the fund will be released only on the basis of progress of the project, in a

phased manner and the transfer of funds should be for each stage .

Government have examined the matter in detail and are pleased to accord Administrative sanction to the Proposal for “Establishing Dairy Innovation Zone by collaborating with Kerala State Start-up Mission(KSUM)” under the Scheme : Rural Dairy Extension and Advisory Services with a State plan outlay of Rs 10.00 lakh (Rupees Ten Lakh Only) under the Head Of Account 2404-00-102-96-34-3 Other Items subject to the following Special conditions and General Conditions.

Special Conditions

- (i) The fund will be released only on the basis of progress of the Project, in a phased manners.
- (ii) The transfer of amount should be for each stage.

General Conditions.

- (i) The rules,orders,formalities and procedures should strictly be complied with for the implementation of the Scheme. The norms of financial propriety shall be adhered to in toto.
- (ii) The expenditure will be met only from the provision available under the appropriate head of account.
- (iii)The fund released will be based on actual requirement.
- (iv)Store Purchase Rules should strictly be adhered to for all kinds of purchases Tender/e-Tender and other stipulated formalities should be followed wherever necessary.
- (v) Post creation and purchase of vehicles are not admissible under the scheme.

The Director,Dairy Development Department will take further action for the implementation of the above scheme strictly in accordance with

the existing rules and standing orders.
