3) In the circumstances, Government having accepted the recommendation of the Working Group Meeting held on 12.05.2022 are pleased to accord Administrative Sanction for the proposal for the Establishment of Sports Business incubators in reputed Colleges and Institutions (Conduct of Sports Hackathon and Establishment of Sports Innovation Zone) for an amount of Rs.35,00,000/-+GST (Rupees Thirty Five Lakh only) under the head of account "2204-00-104-59-Special Projects (P)" during the current financial year , subject to the following general conditions should be followed wherever necessary.

- i. All the rules, formalities and procedures shall be strictly followed for the implementation of the scheme. The norms of financial propriety shall be adhered to in toto.

- ii. The expenditure would be met from the provisions available under the appropriate head of account.
- iii. The fund release will be based on actual requirement and the fund released should not be parked in banks.
- iv. Stores Purchase Rules shall be strictly adhered to.
- v. The agency should be selected through a competitive and transparent process
- vi. Tender/e-tender and other stipulated formalities shall be followed wherever necessary.

4) The Director, Sports & Youth Affairs shall initiate further necessary action for execution of the scheme during the current financial year as sanctioned above.


