ORDER

The Chief Executive Officer, T-TBI in the letter read as 1st paper above furnished proposals for according Administrative Sanction for Rs.25 crore for establishing a new scheme for initiating the Development of Startup Village at Kalamasseri, Kochi in 13.2 acres of allotted land. The total project cost is Rs.35 crore. The requirement for the current financial year is Rs.25 crore.

2. The Special Working Group meeting held on 29.8.2014, as per the minutes read as 2nd paper above, has agreed to accord Administrative Sanction for the proposals of the T-TBI, subject to the specific condition that consultancy fee should be as per the existing Government orders.

3. In the circumstances Government are pleased to accord sanction to the Chief Executive Officer, T-TBI towards the project at a total estimate cost of Rs.35 crore (Rs.Thirty five crore) for establishing a new scheme for initiating the Development of Start up village at Kalamassery, Kochi and for an amount of Rs.25 crore provided under the head of account 4859-02-800-89(P) during the current financial year, allocated in the current year's budget subject to the specific (as above) and also to the following conditions:
