Finance Department – Practice of holding/parking of funds in STSB Accounts under Public Account by Departments and State owned PSUs/Autonomous Institutions - Guidelines for effecting the resumption from STSB Accounts– Approved – Orders Issued.

2. Meeting held by Principal Secretary (Finance) on 30-12-2017.

ORDER

As per the G.O. read above, directions were issued for the resumption of funds from the STSB Accounts under Public Account by Departments and State owned PSU's/Autonomous Institutions holding funds in excess of Rs.1 crore in STSB Accounts upto the end of previous year 2016-2017 and who have not yet spent those amounts as on 30th November 2017, such amounts in the STSB Accounts would be resumed to the Consolidated Fund of the State by debit to that amount. The list of STSBs from where such resumption is made was appended to the GO read above. Reduction in STSB Account and Public Account of the State would be of Rs. 5630 crore, thereby reducing the Public Account by this amount.

It was also ordered that the detailed guidelines to effect the resumption and the procedure for re-allocation will be issued separately. Accordingly the following guidelines are issued for effecting the resumption based on the decision taken in the meeting read as second paper above.

1. The Treasury Officers concerned are authorized to debit the specified amounts (as per the list appended) from the STSBs and will be credited back to the minor head of account "911-Deduct Recoveries of overpayments" below the head of accounts mentioned therein.
2. The Director of Treasuries will issue operational guidelines to be followed by the treasury officers for this credit back.
3. This crediting back is to be completed within 15 days and compliance reported to Government by the Director of Treasuries immediately.
