ORDER

An amount of ₹ 850.00 lakhs was provided in the Budget for the financial year 2020-'21, under the head of account "4859-02-004-99" for the scheme 'Technology Innovation Zone' and as per the Government order read as 1st paper above, administrative sanction has been accorded for the same. As per Government orders read as 1st, 2nd and 3rd paper above an amount of ₹ 7 crores(2.5 crore+2.5 crore+2 crore) has been released to Kerala Startup Mission as 1st, 2nd and 3rd installments respectively. The Chief Executive Officer, Kerala Startup Mission as per letter read as 5th paper above has requested to release an amount of ₹ 150 lakh under the head of account "4859-02-004-99" for the scheme 'Technology Innovation Zone' as 4th installment.

- 2. Government have examined the matter in detail and are pleased to release an amount of ₹ 1,50,00,000 /- (Rupees One Crore Fifty Lakh only) to Kerala Startup mission from current year's budget provision, by debiting the expenditure under the head of account "4859-02-004-99(P)" for the scheme "Technology Innovation Zone" subject to the conditions specified in the Government order read as 1st paper above and the following terms and conditions of fund release:
 - i. The amount shall be transfer credited to PSTSB A/c in compliance of GO

(P)62/2018/Fin dtd.16.04.2018.

- ii. Funds shall be utilized for the purpose for which it is released and not diverted for any other purpose.
- iii. Circular No. 75/09/Fin dated 29.08.2009, Circular No. 8/2018/Fin dated 30.01.2018, Circular No.53/2018//Fin dated 16.06.2018, G.O (P) No. 88/2018/Fin dated 11.06.2018 and G.O (P) No. 100/2018/Fin dated 03.07.2018 should be followed strictly and the amount that can be spent during the current Financial Year only shall be drawn.
- iv. The Utilisation Certificate for the whole amount released should be furnished to Government in due course in the prescribed proforma as appended with GO (Ms) No. 4/2020/Fin dated 09.01.2020.
- v. The filing fee for ROC and other connected expenditure arising due to enhancement of the authorized capital shall be met by the company from its internal resources and government will not provide any fund on this.
- 3. The Under Secretary, Electronics & IT Department shall draw the amount and credit the same in favour of Kerala Start up Mission in their PSTSB Account No. 799012700000248 maintained at Sub Treasury, Kazhakkuttam, which shall be withdrawn only according to actual requirement.
