General Terms & Conditions

1. Eligibility Criteria:

- Should be a Firm/Company Incorporated in India (incorporation certificate to be attached).
- Bidder should be an authorized reseller of Sketchup & Enscape(Optional)(MAF certificate to be attached).
- The bidder must have supplied similar products to government departments/PSUs or organizations as part of previous contracts. Documentary proof for the same(**

Purchase Orders, Completion Certificates, or Work Orders) must be submitted along with the bid.

2. Scope of Supply:

- a) The quotations shall be submitted as per the technical specifications as per **Annexure - I** (Part A and Part B)
- b) Submission of the quotation implies that these conditions of quotation have been read by the quotationer and are aware of the scope of the supply and the quality of the material to be supplied. The final acceptance of the quotation rests with the Chief Executive Officer, Kerala Startup Mission who reserves the right to accept or reject any or all quotations without assigning any reason thereof.

3. Submission of bids (Documents to be submitted)

The quotation should submit the below in 2 separate (technical bid and financial bid) envelopes, the 2 separate envelopes containing each technical bid and financial bid shall be further enclosed within a larger envelope of the bidder and shall be submitted via post/courier/by hand.

a) Technical Bid

The documents shall include the following:

1. Company registration details (Incorporation certificate to be attached)
2. Company profile (Company brochure to be attached)
3. Work completion report (Work completion report with at least 2 work orders to be attached)
4. Copy of GST registration and PAN certificate to be attached.
5. quotation form (The filled up quotation form with GST, PAN, Sign, Name and seal of authorized signatory and name, sign of 2 witness should be clearly mentioned)
6. Annexure 1 (The compilation sheet should be filled with yes or no and with proper remarks).
7. Address of Service centers across Kerala along with the escalation matrix (as part of the software support).
8. Declaration non blacklisting

4. Validity of quotation

- a) The quotation shall be valid for a period of 90 Days from the date of opening of the quotation.
- b) quotationer for any reason whatever, withdraws the quotation after it is accepted or become unable or fails to execute the orders within stipulated delivery period, KSUM shall be at liberty to cancel the order forthwith
- c) No representation for the enhancement of the prices of the accepted quotation or alteration of the terms and conditions will be entertained till supplies are completed.

5. Guarantee of Quality and Warranty of Software supplied:

- a) Guarantee/Warranty and Support and defects liability period-The supplier shall provide full fledged support to KSUM during the tenure of the license.

6. Delivery of Software

- a) The supplier shall deliver the software via mail or hardware based, as required to prevent their damages or deterioration during the transit. The packing shall be sufficient to withstand, without limitation, rough handling during transit.
- b) The equipment containing the software shall be securely boxed, created and protected from mechanical damage, moisture etc. suitable for both storage and transit according to the nature of the material and mode of transport.

7. Price

- a) The price shall be firm and shall include all applicable taxes and charges. Any variation in the duties, levies etc. during the period of supplies shall be charged to the quotationer account. The rates quoted shall be all inclusive, with the delivery, up to destination i.e. KSUM, Kochi .

8. Delivery

- a) The successful quotationer shall complete supplies strictly within the accepted delivery period. Material ordered by the KSUM shall be delivered to destination securely packed as may be necessary.
- b) The equipment containing the software with license shall have to be delivered and installed at KSUM, ISC, KTIZ, Kochi to the satisfaction of the concerned Authority.

9. Payment

The payment will be made by KSUM by e-Transfer to the bank account as mentioned in the bank mandate.

10. Service Facility & Support :

In order to ensure proper and timely after-sales service, contact details with addresses of service centers at Kerala shall be provided along with the bid. The Supplier shall provide services & support on demand towards the installation, registration, activation, maintenance for smooth functioning of the software and upgrades if any, during one year license period with no extra charges. The service shall be initiated within two working days of request and shall be fully resolved maximum within 7 days.

11. Taxes

Suppliers shall be entirely responsible for all taxes, duties, license fees, octroi, road permits, etc., incurred until delivery of the contracted Software to the Purchaser.

12. Termination for Default

The purchaser may, without prejudice to any other remedy for breach of contract, by written notice of default sent to the supplier, terminate the Contract in whole or part:

- a) If the supplier fails to deliver any or all of the Software within the period(s) specified in the order, or within any extension thereof granted by the Purchaser; or
- b) If the Supplier fails to perform any other obligation(s) under the Contract.
- c) If the Supplier, in the judgment of the Purchaser has engaged in corrupt or fraudulent practices in competing for or in executing the Contract.

For the purpose of this Clause:

- a) "Corrupt practice" means the offering, giving, receiving or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution.
- b) "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of Borrower, and includes collusive practice among quotationers(prior to or after bid submission) designed to establish bid

prices at artificial non-competitive levels and to deprive the Borrower of the benefits of free and open competition”.

In the event the Purchaser terminates the Contract in whole or in part, the Purchaser may procure, upon such terms and in such manner, as it deems appropriate, Software or Services similar to those undelivered, and the Supplier shall be liable to the Purchaser for any excess costs for such Software or Services. However, the Supplier shall continue the performance of the contract to the extent not terminated.

13. Claims:

- a) If the software supplied are found different from specification given in the Annexure I or specifications lower than those stipulated in the accepted offer, KSUM shall have the right to totally reject the software supplied and/or to prefer a claim for compensation for the part of Software, which are rejected.
- b) The supplier shall reimburse to KSUM, the actual expenditure incurred, on such software, within 15 (fifteen) days of its demand.
- c) The supplier shall be responsible for arranging the rejected software to be removed at his/her cost from KSUM, Kochi premises.
- d) The supplier shall also compensate for losses, if any, sustained by KSUM due to defective packing and/or wrong marking of the software.
- e) While submitting the quotation, if any of the prescribed conditions are not fulfilled or are incomplete in any form, the quotation is liable to be rejected.
