Expression of interest for setting up a Digital Bank in the Technology Innovation Zone, Kalamassery - Kochi

The Kerala Startup Mission (KSUM) is the nodal agency of the government of Kerala for promoting entrepreneurship in the state. It is also the implementing body for the Kerala Technology Startup Policy that supports the state's startup ecosystem through the various schemes and support programs. KSUM was founded in 2006, with the goal to promote technology-based entrepreneurship activities and to create the infrastructure and ecosystem required to support high-end technology-based startup businesses.

KSUM was designated by the GOK for establishing & operating an innovation incubator hub - Technology Innovation Zone (TIZ) in Kinfra Hi-tech Park, Kalamassery. The Zone is envisioned as a one stop destination for technology innovation, where everything from the consolidation of the idea, to its incubation, acceleration, to mentor support for setting up a successful enterprise and even a squadron of angel investors ready to invest in a bankable idea, is present. The TIZ will act as a self-sustained ecosystem which serves all the interests of the young innovators and entrepreneurs.

Current facilities in TIZ

☐ Integrated Startup Complex

Integrated startup complex (ISC), South Asia's largest innovation hub consisting of a total area of 1.8 lakh Sq.ft with a total capacity of 1000+ work stations.ISC has Premium co-working space, Incubation space, Scaleup/accelerator space, freelance Space, amphitheatre, conference Hall, Cafeteria.

Digital Hub

South Asia's largest product development centre consisting of a total area of 2 lakh Sq.ft with a total capacity of 1500+ work stations.DH will be housing design incubator, healthcare incubator, Center of Excellence (CoE) for Mouser Electronics, co-working spaces, design studios, investors hive and an innovation center.

□ Bionest Kerala

KSUM has set up an incubation hub for the research, innovation, incubation of Biotech startups in association with Rajiv Gandhi Centre for Biotechnology (RGCB). The centre has incubation space, R & D Lab and other necessary facilities for the startups to kick start their operations.

■ Maker Village

The Electronics Incubator set up by Kerala Startup Mission in association with IIITM-K and supported by MeitY (Ministry of Electronics and Information Technology) houses startups working in divergent areas viz Automation, Robotics, Drones, Internet of Things, Autonomous Vehicles, Biomedical Instrumentation, Energy Management etc. They provide incubation space with lab facilities.

□ Knowledge Labs

KSUM has also set up a lab facility with rapid prototyping technology via necessary equipment for the research and development of emerging technologies which helps the startups to turn their ideas into functioning prototypes.

☐ Incubated Companies

Currently TIZ is home for more than 150 high growth technology startup companies from different parts of the company.

Facilities under development

KSUM is in the process of setting up specialized incubators in other Impact areas. Also the facility in TIZ is being expanded to the next phase to provide incubation infrastructure with supporting facilities like AmphiTheater Training Centers, Conference - Meeting Rooms, Digital Studio, Business Center, Pantry area, Guest Lounge etc.

Scope of Work

Setting up a Digital Banking facility for providing banking services for startups in the Technology Innovation Zone. The proposed banking centre should have ATM Facility, Bank account opening, and all digital banking facilities. The facility should have a well versed staff who would be able to guide startups with all the banking facilities and resolve queries. The facility should be functional on all working days except the bank holidays following the normal banking hours.
