- 3. **Sizes and Quantities:** Providing a range of sizes (S, M, L, XL, XXL) with flexibility to adjust quantities based on registration.
- 4. **Timely Delivery:** Ensuring delivery of all T-shirts by 25 November 2024.
- 5. **Quality Assurance:** Guaranteeing quality control in terms of fabric, colour, print durability, and overall finish.

Submission Requirements

Vendors are requested to include the following in their EOI submission:

- 1. **Company Profile:** Brief background of the company, years in operation, relevant experience, and past clients.
- 2. **Portfolio:** Examples of similar projects completed, preferably for large-scale events or corporate clients.
- 3. **Technical Specifications:** Details of materials, production methods, and any certifications (e.g., eco-friendly, fair trade).
- 4. **Pricing Structure:** A preliminary quote based on estimated quantities, including bulk discount options.
- 5. Timeline: Proposed timeline for design, production, and delivery.
- 6. **Sustainability Practices:** Information on any sustainable or eco-friendly practices followed by the company.
- 7. **T shirt requirements:** Attached as annexure I. Requirements will be considered separately and separate quotes needs to be provided

Evaluation Criteria

EOI submissions will be evaluated based on:

- Quality and durability of materials proposed.
- Vendor's ability to meet the project timeline.
- Cost-effectiveness and flexibility of pricing.
- Alignment with sustainability goals.
- Past experience and client references.
